PARKING RULES AND REGULATIONS 2020/2021

***Parking guidelines are set up and approved by the Pickerington Board of Education (BP JHFD/JHFD). A Student driver who is in violation of any of these guidelines will be disciplined per adopted Board Policy (BP JEGA/JFC/JGF).**

***Fee for parking is \$ 15 per year.**

***Student drivers should park only in “student” designated areas. Parking permits are required to park in these areas. Areas designated VISITORS and STAFF are not to be used by student drivers.**

***Parking in an unauthorized area or failure to display your parking permit from the rear view mirror could result in school discipline, possible loss of driving privilege and/or car being towed from the lot at owner expense. Automobiles parked illegally in marked Handicap or Fire Lanes are subject to fines by the Pickerington Police Dept. and possible towing.**

***Student drivers are to display the parking permit on the rear view mirror; the student pass number should be visible from the front of the car. There are specific passes for students and staff parking area. Only park in appropriate, assigned areas.**

***I am a certified licensed driver in the State of Ohio and have current automobile insurance on the vehicle that is driven to school. I meet all the requirements that are set forth by the Bureau of Motor Vehicles and I am not under any current license suspension.**

***The PICKERINGTON LOCAL SCHOOL DISTRICT is not responsible for any damage/theft that is incurred on PLSD property.**

***The student driver is held responsible to read the Student Agenda issued at the start of the school year for information regarding parking rules.**

***Having a vehicle on PLSD property is considered consent by the student driver to a search of the vehicle if there is reasonable suspicion that the vehicle contains items which could be in violation of PLSD discipline codes.**
